**GENERAL TERMS & CONDITIONS CORRESPONDING
TO THE SUBJECT TENDER**

1. Sealed/Closed Quotations are to be submitted in a two Bid System (1) Technical Bid and (2) Commercial Bid, separately as per details given below:-
 - 1.1 Technical Bid be submitted in a separate sealed envelope superscribing thereon:

 - 1.2 Commercial Bids be submitted in a separate sealed envelope superscribing thereon:
**Tender for Commercial Bid for SOLAR WATER HEATER SYSTEMS
Tender No. SP/GS/SOLAR-WHS/2009-10/51 dated 21/08/2009.**
 - 1.3 Both the envelopes be submitted in another master envelope in sealed condition superscribing thereon:
**Tender for Technical Bid & Commercial Bid for SOLAR WATER HEATER SYSTEMS

2. The following are to be noted:-
 - 2.1 If the Commercial Bid and Technical Bid are enclosed in same envelope instead of in two separate closed/sealed envelopes, the tender would be rejected.
 - 2.2 On the date of opening of tender only Technical Bid would be opened and the Commercial Bid would be kept in the sealed condition with IGRUA.
 - 2.3 The Commercial Bid of only those Tenderers who qualify the Technical Aspects would be opened, the date and time for which would be notified in advance to the successful Tenderers.
 - 2.3.1 The Tenderer should sign with date on all the papers of both the Technical Bid and Commercial Bid.
 - 2.3.2 The Technical Bid should not contain any indication of the price.
 - 2.3.3 The price quoted should be valid for acceptance for a minimum period of 90 days from the date of opening of the Technical Bid.
 - 2.3.4 The Bids should be neatly filled/typed. Correction, if any, should be duly authenticated with full signature of the person signing the tender, failing which the tender is liable to be rejected.

- 2.3.5 The quotation should be submitted through Post/or Courier or Personally as per tender procedure. Under no circumstances, the quote should be sent by E-mail or Fax.
- 2.3.6 IGRUA will not be responsible for the quotation lost in transit or not received in time including postal delay.
- 2.3.7 IGRUA reserves the right to either accept or reject the offers or split the quantities. IGRUA is not bound to accept the lowest or any other tender. IGRUA's decision will be final and no objections about the tender will be entertained. IGRUA reserves the right of not awarding any contract to anyone or of awarding the contract to one or more tenderers.
- 2.3.8 The Tenderer shall not be at liberty to withdraw or modify the tender or any terms and conditions, thereof before expiry of aforesaid validity period of 90 days. Tenderers are required to clarify such points on which clarification is asked for by the Competent Authority. Any withdrawal or any later modification made within the said period shall be liable for rejection in consequences thereof in addition, EMD will be forfeited. Conditional offers, if any, are liable to be rejected at the sole discretion of IGRUA.

3. Responsibility of the Tenderer:

It is sole responsibility of the Tenderer to obtain and verify any and all information required by it for the purpose of completing the form of tender, prior to submission of its tender.

4.1 Earnest Money/Security Deposit:

Earnest Money Deposit (hereinafter referred to as EMD) of Rs 10,000/- by way of Demand Draft issued by any Nationalized Bank in favour of IGRUA payable at Raebareli.

4.2 In case EMD is not found attached or not submitted in the mode specified, the tender will be rejected.

4.3 The EMD will be refunded to the un-successful Tenderers. The Earnest Money of successful Tenderer will be kept as Security Deposit.

4.4 The EMD will be forfeited in the event of the Tenderer withdrawing the Bid after opening of the Tender and till award of the Contract and/or refuses to accept the Contract, if awarded.

5. Delivery Schedule: The delivery schedule must be clearly indicated in the Technical Bid.

6. The required technical specifications of SOLAR WATER HEATER SYSTEMS are as per Annexure “B”.
7. The following are required to be submitted with Technical Bid:-

 - Proof of Income Tax Clearance/PAN Number

 - Proof of Similar Supply not less than Rs 3 Lakhs to a single party during the last three years.
